## THE EPIPHANY OF THE LORD - HOLYDAY OF OBLI-

**GATION:** This major feast of Christmastide, a holyday of obligation, is celebrated on 6th January. I note, from the Year Book, that Masses on holydays of obligation have been at 7.00 p.m. (Vigil) in Spilsby and at 7.00 p.m on the day itself in Skegness, obviously to facilitate those who work coming to Mass. This is very good and will continue. However, there are many people no longer in the first flush of youth who may be worried about coming out at night and so, in addition to those Masses, I intend to say Mass also at 10.00 a.m. In Skegness and at 12.00 noon in Spilsby for the Epiphany and, if you think it a good idea, on holydays generally.

WORK ON THE CHURCH IN SPILSBY: In relation to health and safety, there will be some electrical work carried out on the church in Spilsby on 3rd - 4thn January, mostly involving the fitting of new photo-sensitive lights outside the church. On a date to be agreed, a light will also be fitted above the door from the sacristy to the sanctuary. These are matters of importance for health and safety, since, in the dark, there is no light at all at those points. Due to the work on Tuesday, there will be NO MASS in Spilsby at 12.00 noon on 4th January.

**SOME REMINDERS RE COVID.** If you have been to Church and subsequently contract the coronavirus, please notify me or one of the steward. Singing is permitted only when wearing a mask. The **latest instructions from the diocese**, as of 10th Dec., in the light of the government's directions, are that, in places of worship:

- 1. Masks must be worn.
- 2. Social distancing must be maintained.
- 3. Ventilation must be ensured before/ during ceremonies.
- 4. Hands, seats and other surfaces must be sanitised.

Please, observe these strictly, for the safety of all.

THE OBLIGATION OF SUNDAY MASS.: The obligation to attend Mass on Sundays and on holidays of obligation (or the Vigil Mass the evening before) is the way we are to keep holy the Day of the Lord, the minimum we should do. This duty does not apply if we are physically incapable of attending Mass, such as when we are in hospital or when there is a real moral impossibility of attending, eg where someone could reach the church physically, but would put their health or that of others at serious risk; hence to does not bind strictly in the pandemic. Hence, a person should not come to church if they have the virus, are very ill or compromised in their health, or cannot risk exposing relatives in such a condition to real added danger. Those unable to come to Mass should follow Mass on the television or radio until they are able to come in person. However, if people can go to the supermarket, to work, etc., then they can and should come to Mass. People are better protected in our churches than they are in many shops or even on public transport, in that sanitising is more frequent, distancing more secure, and masks are worn by most.
